



UPWEY SKATEBOARD RACE – TERMS & CONDITIONS

Please ensure you have read all the terms and conditions and agree to abide by them prior to signing your registration indemnity form. These terms and conditions have been devised to keep the event safe, fair and well coordinated.

Safety Requirements:

All participants are expected to wear the following items to ensure safety:

1. Helmet
2. Elbow Pads
3. Knee Pads
4. Wrist guards and/or downhill gloves
5. Long pants and long sleeve top

•Every participant will be checked to ensure compliance with these safety standards.

*Spare Helmets and Knee and Elbow Pads will be available for participants use at the event if required, however it is recommended that where possible participants utilise their own equipment.

•Participants will abide by instructions as given by Simply Skateboarding officials and Event Staff at all times or face immediate disqualification

Skateboard Requirements:

•All Skateboards will be scrutineered to ensure safety for participants and spectators.

Street / Park boards, Cruiser boards and Long boards are all acceptable to race on, however any modifications and or mechanical devices will result in your entry being denied.

Entry Requirements:

•Entry is at the risk of each participant. By signing the indemnity registration form you are acknowledging your awareness of the dangerous nature of the sport and the potential for risk or death. Please ensure you read the indemnity registration in full.

STEP 2: All participants accept and agree to:

1. Registering with a signed and completed entry form on the day by 11:30am
(In the case of Under 18's, you must have a parent / guardian present to enter.)
2. Abide by the safety and skateboard requirements
3. Abide by any instructions given to them by officials and event staff

Declaration and Waiver Release and Indemnity Deed (All persons must complete this document prior to participation.)

The activities described include adventurous recreational activities and are not without inherent risk. Simply Skateboarding thanks you for reading this document carefully. TO: Simply Skateboarding Pty Ltd. its directors, employees, principals, agents and independent contractors, (collectively referred to as "Simply Skateboarding"): I confirm the following is true and correct and that Simply Skateboarding has relied on my answers in allowing me to participate in recreational activities of and incidental to things including skateboarding, inline skating, scooter riding and BMX riding ("the activities"). **Release:** In consideration of Simply Skateboarding permitting me to participate in the activities, I hereby grant permission to Simply Skateboarding operators and owners, their successors and sponsors to use my name, image and likeness in direct connection with the activities for promotional broadcasting or reporting purposes in any and all manner and media, unless restricted by Privacy Legislation. **Express Voluntary Assumption of Risk:** I understand that I, and each participant in the activities, will be engaging in activities involving a real risk of serious injury or even death from various causes including but not limited to equipment failure, accidents with other participants, spectators, course or weather conditions or other causes. I voluntarily accept all risks necessarily flowing from my participation, which could result in loss of life or injury. **Liability Release and indemnity:** I hereby release Simply Skateboarding and all persons or corporations associated directly or indirectly with the conduct of the activities from all claims, demands and proceedings arising out of my participation and hereby indemnify them against all liability (including liability for their negligence and the negligence of others) for all injury, loss or damage arising out of or connected with my participation in the activities. This release shall extend to and include Simply Skateboarding and Simply Skateboarding's owner, partners, managers, officers, agents, contractors, any club, organization and volunteers including medical and paramedical personnel appointed for the activities, the owners, licensees, and occupiers of land on which the activities or any part of it are conducted or which is involved directly or indirectly with the activities in any manner whatsoever and promoters, sponsors and activities organizers. This release and indemnity continues forever and binds my heirs, executors, personal representative and assigns. **Equipment and Facilities Inspection:** I agree that before I participate in the activities, I will independently inspect the related facilities and equipment. I will immediately advise Simply Skateboarding of any unsafe condition that I have observed. I will refuse to participate in the activities until all unsafe conditions observed by me have been remedied. I acknowledge that reasonable safety precautions are undertaken by Simply Skateboarding (such as supervision, helmet safety checks), but such are a service to me and other participants and are not a surety of safety. **Protective Equipment:** As an activities participant I hereby agree to supply or hire and wear a suitable helmet, knee pads, elbow pads, wristguards, and /or downhill gloves, runners or covered shoes, plus a long sleeve tee shirt and thick pants as the minimum protective equipment requirements at all times whilst I am taking part in the activities. **Physical Fitness:** I have independently assessed the activities and I am physically fit to participate in the activities in which I have chosen to participate and have not been advised otherwise by a medical practitioner. I do not have any possibly relevant pre-existing medical or physical conditions which have not been disclosed to Simply Skateboarding. **Medical Treatment:** I consent and consent on behalf of the child for whom this waiver has been signed to receiving any medical, eg first aid, treatment that Simply Skateboarding considers reasonably necessary during or after the activities. **Personal Property:** I hereby acknowledge that I have the sole responsibility for my personal property during the activities. I acknowledge the terms and conditions of this document are contractual in nature, are intended to have legal effect and are not a mere warning or recital. Simply Skateboarding is not responsible for my decision to participate in the activities and I was not induced by Simply Skateboarding to do so. I acknowledge my registration is not transferable to any other person. I have read this document, understand its contents and complete it of my own free will.
